






Biologische kwaliteit van regionale wateren volgens Kaderrichtlijn Water per provincie, 2019









Urgenda wint na 7 jaar de Klimaatzaak. Op 20 december 2019 deed de Hoge Raad haar finale uitspraak in de Klimaatzaak van Urgenda tegen de Nederlandse Staat. De overheid moet in 2020 25% minder broeikasgassen uitstoten dan in 1990.

Ook de hoogste rechter oordeelt dat klimaatverandering een grote bedreiging vormt en dat de Staat een zorgplicht heeft om zo snel mogelijk de Nederlandse emissies te verlagen. Een reductie van minder dan 25% in 2020 is in strijd met het Europese Verdrag voor de Rechten van de Mens.

De rechtbank oordeelde op 24 juni 2015 al dat de Staat de verplichting heeft de uitstoot van broeikasgassen vóór 2020 met 25% te reduceren ten opzichte van 1990. Zie voor meer






